PART:

1. CITATION

This Bylaw may be cited as "Traffic Bylaw Amendment One"

2. GOVERNING LEGISLATION

The Municipalities Act (The Act) shall prevail in all circumstances where there might arise a conflict between The Act and the Traffic Bylaw Amendment One.

3. PURPOSE

Bylaw No. 12-17 is hereby amended by replacing "Schedule "B" – NOTICE OF VIOLATION" with a revised version, as forming part of this Bylaw and as may be amended from time to time.

4. COMING INTO FORCE

This Bylaw shall come into force and be in effect on the final reading thereof.




