

Creative Kids Granting Guidelines

Please complete your application in full.
Incomplete applications cannot be considered
for Creative Kids funding.

- Applicants must be 19 years-old or younger (applicants under 16 must have a parent or guardian apply on their behalf).

- Maximum funding up to \$750 per calendar year per child.

- Applicants may apply for funding more than once in a calendar year.

- Applicants must be endorsed by a third-party adult who is not a relative and is able to verify the financial need of the applicant.

- Applications must be received a minimum of 30 days before the start date of the activity/program AND meet the local or provincial committee deadlines.

- Applications must include a description of the creative, artistic or cultural elements of the activity/program.

- Funds will be dispersed directly to the organization or instructor providing the program or activity.

- Eligible costs include: participation/registration fees, equipment, supplies, festival costs, etc.

- Priority funding may be given to payment of participation/registration fees.
